<p>b(7)(c)-3 ON 1/20/03, [REDACTED] AKA [REDACTED] b(7)(c)-5 b(7)(c)-5 INTERNMENT SERIAL NUMBER (ISN) [REDACTED] WAS INTERVIEWED AT CAMP DELTA, GUANTANAMO BAY, CUBA. THE INTERVIEW WAS CONDUCTED BY FEDERAL BUREAU OF INVESTIGATIONS SPECIAL AGENT [REDACTED] AND UNITED STATES ARMY CRIMINAL INVESTIGATION COMMAND SPECIAL AGENT [REDACTED]. THE INTERVIEW WAS CONDUCTED IN THE ARABIC LANGUAGE AND TRANSLATED BY b(7)(c)-6 b(7)(c)-1 CONTRACT LINGUIST [REDACTED]. AFTER BEING INFORMED OF THE IDENTITY OF THE INTERVIEWING AGENTS, [REDACTED] PROVIDED THE FOLLOWING INFORMATION:</p> <p>b(7)(c)-5 b(7)(c)-2 THE OBJECTIVE OF THE INTERVIEW WAS THE CONTINUATION OF RAPPORT BUILDING AND TO OBTAIN INFORMATION REGARDING THE FINANCING OF TRAINING CAMPS IN AFGHANISTAN.</p> <p>b(7)(c)-5 [REDACTED] IMMEDIATELY STATED THAT HE DID NOT WANT TO ANSWER ANY QUESTIONS. HE ONLY WANTED TO KNOW HOW HIS BROTHER, [REDACTED] WAS DOING. [REDACTED] STATED THAT HIS BROTHER ATTEMPTED SUICIDE ON 1/17/03 WHILE IN ISOLATION. ONE OF THE DETAINEES IN [REDACTED] CELL BLOCK, ALSO IN ISOLATION AT THE TIME OF THE INCIDENT, TOLD [REDACTED] THAT [REDACTED] HAD BEEN BEATEN BY THE GUARDS AND WAS DEAD. [REDACTED] WAS TOLD THAT [REDACTED] WAS IN THE HOSPITAL; HOWEVER, [REDACTED] DID NOT BELIEVE THE GUARDS AND REQUESTED THAT HE BE ALLOWED TO VISIT [REDACTED] IN THE HOSPITAL.</p> <p>b(7)(c)-5 b(7)(c)-5 b(7)(c)-5 b(7)(c)-5 b(7)(c)-5 b(7)(c)-5 b(7)(c)-5 [REDACTED] STATED THAT HE HAD MADE NUMEROUS REQUESTS TO SEE HIS FRIEND. [REDACTED] THEN STATED, "JUST AS WE KILLED HIM; THEY WILL KILL IN REVENGE." HE THEN COMMENTED THAT THE DETAINEES IN ISOLATION ARE BEING MISTREATED BY FORCE. WHEN ASKED IF HE HAD PERSONALLY WITNESSED ANY OF THIS, [REDACTED] REPLIED THAT HE WAS TOLD THIS BY HIS BROTHERS. b(7)(c)-5</p> <p>b(7)(c)-5 b(7)(c)-5 [REDACTED] WAS THEN ASKED TO PROVIDE MORE DETAILS ABOUT HIS COMMENT REGARDING REVENGE. HE STATED THEY ARE SURE HIS BROTHER IS DEAD AND VERY SOON WE WILL FEEL HIS REVENGE. SEVERAL ATTEMPTS TO REESTABLISH DIALOGUE WITH [REDACTED] FAILED.</p> <p>b(7)(c)-5 b(7)(c)-5 b(7)(c)-5 THE INTERVIEWERS THEN LEFT THE ROOM IN ORDER TO OBSERVE [REDACTED] FROM THE MONITORING ROOM. [REDACTED] TURNED HIS CHAIR SO HIS BACK FACED THE TWO-WAY MIRROR AND BEGAN CHANTING VERSUS FROM THE KORAN. AFTER A COUPLE OF MINUTES, HE SUDDENLY PAUSED, TURNED HIS HEAD TO THE RIGHT AND FOCUSED ON THE PROPAGANDA PICTURE, WHICH WAS HANGING ON THE WALL. APPROXIMATELY ONE MINUTE PASSED, BEFORE HE RETURNED TO CHANTING.</p>
