Dear Mr. Cohen,

Please accept our best wishes and greeting from Guantanamo Prison. Thank you talking to me on the telephone on July 15, 2008, it certainly gave me peace of mind and accordingly I conveyed to my other inmates to calm them down. CRC representative visited us on July 01-2, 2008 who created chaos & confusion by advising us that US government is releasing us and sending to Algeria we all are slightly confused and we were all very extreme suspect. Then after few days Judge Advocate General (JAG) and Staff Judge Advocate visited us and promised us to talk to you (Our attorneys)

It is very unfair keeping us in extreme conditions where Administrative Review Board has eleven or years ago. Years and years are going by in strict isolation. We are thousands of miles away from our loved ones and sweet home, friends and relatives. On the conceal of day & night, winter - Spring and Summer, congregating prayers & Friday Sermon, love & festival, family life & community living we are faring away from our sweet and feather mind. Indeed we are in a very difficult condition. We wish and pray that no human soul should ever go through this ordeal.

Since our captivity we have been extensively interrogated and investigated by various US agencies under severe conditions. All informations about us and family members have already been compiled ages ago. It took many years to separate Executive and Judiciary but here in Guantanamo the lawless is enforcing the PHAROH of Egypt and Hitler of Germany.

American believe in Justice, Equality and Human Rights, but the administration have been avoiding justice and ignoring basic Human Rights. We do believe in justice based on equality, which should certainly be punished even though dishonestly & honorably released. "Right and wrong. Between these unless just justice serves." Shakespeare in (Twelfth Night i. 3.116)

There was a historical judgment US Supreme Court on June 12, 2008

And there was an order by the Roberts' Appeal in D.C. Circuit Court  
 SRT declaring Enemy Combatant of case of PARHAT v. GATES  
 Case no. 06-1397 that PARHAT is not an Enemy Combatant. Historically  
 Since our captivity no prisoner has been released by applying justice, we  
 are not satisfied. No, no, we are not satisfied, and we will not be satisfied  
 until justice falls down like water and righteousness like a mighty stream.  
 Martin Luther King Jr., Aug 28, 1963.

Guantanamo Prison is comparable to HELLTON, SATAN INN or  
 DYSTOPIA, we have no control of Air, Water, Climate, Clothes, Food,  
 Human Contact, light and Medical treatment but out captor proudly and  
 arrogantly controlling ignoring the world Community. In these condition  
 of confinement in our cell affecting our health and psychology, we  
 aging fast and our health is deteriorating fast.

I thought it said in every ticks:

I am so sick, so sick, so sick

O death come quick, come quick, come quick.

In the beginning we are about 800 prisoners here from 40 different  
 countries, more than 550 have been release without applying any law and  
 holding is without any law. Both US Presidential Candidate Barack  
 Obama Democratic candidate and John McCain, Republican candidate  
 said that the Guantanamo Prison should be closed its a disgrace to America's  
 reputation. We ask other nations for Human Rights where we don't see  
 rights given to our captors. It is a deviation of basic teaching of  
 Holy Bible, Matthew (7:5) "Hypocrite! First remove the plank from your  
 own eye, then you see clearly to remove the speck from your brother's  
 eye." and Matthew (7:12) "Therefore, whatever you want men to  
 do to you, do also to you." This is the Law and the Prophets. My  
 request to you is please look into possibility to ask question to the Presidential

I am having a rare opportunity to convey you my feeling in English  
it may be the first and last time but I request you kindly write me  
in Arabic. In the end I would like to narrate Shakespeare:

"Blow blow thou winter wind, Thou art not so unkind as man's ingratitude  
Thy breath is not so keen because men are not seen although thy breath be true  
Heigh ho - singing high he left the green wood lonely most friend ship is  
forsaking and leaving mere folly."
