1. ACTION REQUIRED: ACTION REQUIRED: -- PLEASE ENSURE THAT SUBSTANTIVE PORTIONS OF INFORMATION BELOW ARE SHARED WITH FBI HOS

2. OVERALL STATE OF PLAY: SUBJECT IS CURRENTLY IN THE SIXTH DAY OF THE ISOLATION PHASE. AS REPORTED PREVIOUSLY, [REDACTED] (SUBJECT) BEGAN THE ISOLATION PHASE OF THE [REDACTED] CYCLE ON 18 JUNE 2002 AT APPROXIMATELY 1600 HOURS. THE ISOLATION WILL CONTINUE FOR APPROXIMATELY THREE WEEKS UNTIL THE [REDACTED] RESUME CIRCA 11 JULY 2002. WE UNDERSTAND THAT IT MAY BE NECESSARY UNDER EXCEPTIONAL/EXCEPTIONAL AND URGENT CRISIS CIRCUMSTANCES TO INTERRUPT THE CAREFULLY SCRIPTED ISOLATION AN RISK LOSING ITS INTENDED EFFECTS. WE ARE PREPARED TO COVER THIS CONTINGENCY. JUST TO REVIEW, THE GOAL OF ISOLATION IS TO INDUCE DOUBT AND UNCERTAINTY ON THE PART OF THE SUBJECT ABOUT HIS DISPOSITION. DISRUPTING THE ROUTINE TO WHICH SUBJECT HAS BECOME ACCUSTOMED AND LIMITING HIS CONTACT WITH PEOPLE WILL INCREASE PSYCHOLOGICAL PRESSURE. ISOLATION WILL LIKELY BE HIGHLY DISCONCERTING TO THE SUBJECT GIVEN THE EXTENT OF HIS PRE-CAPTURE LEVEL OF ACTIVITY AND AFFINITY FOR INTERACTION WITH [REDACTED] AND HIS GENERALLY INTENSIVE POST-CAPTURE RATE OF INTERACTION WITH TEAM MEMBERS. IN THE OPINION OF TEAM PSYCHOLOGISTS, INTERRUPTING INSOLATION FOR ANYTHING LESS THAN EXCEPTIONAL/EXCEPTIONAL CIRCUMSTANCES MAY UNDERMINE THE PROCESS IN A WAY FROM WHICH IT IS DIFFICULT TO RECOVER. HOWEVER, IF AN EXCEPTIONAL/EXCEPTIONAL CIRCUMSTANCE OCCURS SUCH AS NEED [REDACTED]

[REDACTED] A PREPARED PACKET WITH SPECIFIC WRITTEN INSTRUCTIONS WILL BE PRESENTED TO SUBJECT FOR HIS FEEDBACK WITHIN THE STRUCTURE OF THE ISOLATION PHASE. SUCH CONTACT WILL BE ACCOMPLISHED A WAY THAT MINIMIZES THE DISRUPTIVE EFFECT. THE RESULTS ASSOCIATED WITH THE SUBJECT'S RESPONSE WILL BE IMMEDIATELY FORWARDED TO ALEC/HQS. [REDACTED] TEAM MEMBERS IC SERE PSYCHOLOGIST, OPERATIONAL/SERE PSYCHOLOGIST, [REDACTED] OFFICER ARE PREPARED TO HANDLE ANY DEVELOPMENTS WHICH MAY ARISE. INTERROGATORS WILL RETURN ON SHORT NOTICE, AS REQUIRED.

3. ATMOSPHERICS/BEHAVIORAL COMMENTS: SUBJECT SPENT THE TIME BETWEEN THE LAST REPORTING PERIOD AND THIS ONE COMPLETELY ISOLATED EXCEPT FOR TWO ROUTINE 20-MINUTE MEDICAL TREATMENT SESSIONS. DURING THE NIGHT AND DAY, SUBJECT ATE, PRAYED, DRANK FLUIDS, WALKED ABOUT HIS CELL, TWIDDLED HIS THUMBS, AND SLEPT FOR RELATIVELY SHORT PERIODS OF TIME. WHEN AWAKE, HE MOST OFTEN RECLINED ON THE PAD OR SAT ON THE PAD AND LEANED HIS BACK AGAINST THE WALL. HE BUSIED HIMSELF WITH PERIODIC FIDGETING WITH HIS NOSE, FINGERS, TOES, AND OTHER APPENDAGES. THE SUBJECT APPEARED BORED AND SHOWED NO SIGNS OF SEVERE EMOTIONAL DISTRESS. ON THE NIGHT OF 23 JUNE, THE SUBJECT CIRCLED HIS CELL SIX TIMES IN AN APPARENT ATTEMPT TO EXERCISE AND STRENGTHEN HIS LEG. THIS IS THE MOST CONCERTED SPONTANEOUS EFFORT TO EXERCISE THAT HAS BEEN OBSERVED TO DATE. IN ADDITION, THE SUBJECT WAS SEEN SLOWLY TURNING HIS TORSO AND HEAD FROM SIDE IN AN APPARENT EFFORT TO STRETCH HIS BACK AND NECK MUSCLES. TWO MEDICAL SESSIONS WERE CONDUCTED AS A MEANS OF INTERFERING WITH THE SUBJECT'S TRACKING OF TIME. THE FIRST SESSION OCCURRED AT 0900 AND THE SECOND AT 1800. BOTH SESSIONS PROCEEDED WITHOUT INCIDENT. THE SUBJECT SLEPT FOR A LONG PERIOD OF TIME BETWEEN THE TWO SESSIONS AND HAS NO WAY OF TRACKING HOW LONG HE SLEPT. HE RECEIVED HIS NORMAL COMPLEMENT OF FOOD AND FLUIDS AND IMMEDIATELY ATE SOME OF THE BEAN, RICE, AND VITAMIN SUPPLEMENT MIXTURE AFTER EACH MEDICAL CARE SESSION. THE SUBJECT DID NOT APPEAR TO MAKE ANY ATTEMPTS TO DOODLE OR WRITE ON HIS NOTE PAPER. THE SHEETS OF NOTE PAPER REMAINED BLANK. IN ADDITION, THE SUBJECT DID NOT WRITE ON THE LARGE RESPONSE SHEET LEFT FOR HIM TO USE TO IDENTIFY DETAILS RELATED TO CURRENT OR FUTURE THREATS.
