ATMOSPHERICS/BEHAVIORAL COMMENTS: SUBJECT SPENT THE TIME BETWEEN THE LAST REPORTING PERIOD AND THIS ONE COMPLETELY ISOLATED EXCEPT FOR A SINGLE ROUTINE 30-MINUTE MEDICAL CARE SESSION (0800-0830, 28 JUNE 2002). DURING THE NIGHT AND DAY, THE SUBJECT'S ACTIVITY INCLUDED EATING FROM HIS BOWL OF BEANS AND RICE (AUGMENTED BY VITAMINS), DRINKING WATER AND ENSURE, WALKING ABOUT HIS CELL, SINGING, PRAYING, AND SLEEPING. THE SUBJECT ALSO TOOK TIME TO STRETCH HIS BACK, NECK, AND SHOULDERS.
