On Friday 07/09/2004 and Monday 07/12/2004, emails were sent to Bureau personnel who served in any capacity at GTMO, requesting any observation of aggressive mistreatment of detainees. There were a total of 530 personnel who were identified and sent the email. As of Tuesday, 07/13/2004 morning, there have been 163 responses received. There have been 14 employees who have identified themselves as observing some sort of mistreatment, but unsure if this was within DOD interview guidelines. The majority of the "positive" responses have stated detainees were subjected to "strobe lights" aimed at their face, cold interview rooms and extremely loud music. Others have documented their observations in EC format. I will continue to provide updates as the results come in.

After day one of the GTMO email survey, I handled approximately 150 email responses and about the same in phone calls. There were 12 Bureau employees who have been marked as possible interviews, one to include observing mistreatment in Afghanistan and a Lab employee who took photos of a detainee with injured eyes.
