FURTHER DENIED ANY KNOWLEDGE OF UBL'S ASSOCIATION WITH AL-OAEDA. b6 -3,4 b7C -3,4 b7D -1 b7F -1 COULD NOT RECALL HIS NAME AND WAS UNABLE TO PROVIDE A DESCRIPTION. ь1 (S) b6 -3,4 b7C -3,4 b7D -1 b7F -1 WAS THEN ASKED IF HE WAS ENCOUNTERING ANY PROBLEMS OR KNEW OF b6 - 3, 4ANYTHING WHICH SHOULD BE BROUGHT TO THE INTERVIEWER'S ATTENTION. HE b7C -3.4 STATED THAT A LOT OF THE BROTHERS WERE STILL UPSET ABOUT THE DETAINEE b7D -1 WHO HAD ATTEMPTED SUICIDE SIX DAYS EARLIER. SEVERAL OF THE BROTHERS b7F -1 WERE STILL SAYING THAT HE WAS BEATEN BY THE GUARDS. HE WANTED TO KNOW IF HIS BROTHER WAS STILL ALIVE AND WONDERED IF A COUPLE OF BROTHERS COULD VISIT HIM TO ENSURE THAT HE WAS NOT DEAD. HE FURTHER COMMENTED THAT SEVERAL OF THE BROTHERS WERE EXTREMELY UPSET, AND HE WAS AFRAID THAT b6 -3,4 OTHERS MIGHT ATTEMPT SUICIDE. HE NOTED THAT SEVERAL OF THE BROTHERS WERE BECOMING WEAK AND BEGINNING TO LOSE THEIR FAITH. STATED THAT b7C -3,4 SEVERAL BROTHERS BECAME EXTREMELY AGITATED WHEN GUARDS REPORTEDLY b7D -1 TOLD SEVERAL OF THE DETAINEES THAT THEIR BROTHER HAD ATTEMPTED SUICIDE b7F -1 BECAUSE HIS FELLOW BROTHERS WERE NOT NICE TO HIM AND HE DID NOT FIT IN. STATED THE ISSUES REGARDING THE KORAN LED TO THIS. IT WAS JUST A b6 - 3.4MATTER OF TIME BEFORE SOMETHING LIKE THIS OCCURRED. HE COMMENTED THAT b7C -3.4 THE KORAN SHOULD NOT BE USED AS A FORM OF PUNISHMENT. ALSO, THE b7D -1 SEARCHING OF THE KORAN NEEDS TO BE LOOKED INTO. THE GUARDS NEED TO BE b7F -1 MADE AWARE OF HOW THEY ARE HUMILIATING THE KORAN.
